We are still busy ploughing our way through the many responses and these will be used, in addition to the headline results that went to recent Overview & Scrutiny Committees, to produce a consultation report, which will be considered as part of papers going to Cabinet on 22nd February and full Council on 10th March.

Following this, a summary for general distribution will also be produced.

Proposal to Introduce a Council Tax Premium on Second Homes

Recent new legislation means that we have been able to pick up on suggestions we received during the 'PCC is Changing Events' we held across the county last October, and the feedback we had on this idea, as part of the recent budget consultation.

We are proposing to introduce a Council Tax premium on second homes from 1st April 2017 onwards. We will be contacting owners of all properties we currently have listed as 'second homes' over the next month to ask them for their views.
